

SUCCESS STORY




Ms. H became homeless when her family was evicted. She called Path of Life Ministries (POLM) Street
Outreach hotline and requested assistance. The Community Shelter was full, so they placed her in the POLM Non-Congregate Emergency Shelter for one month under the Motel Hotel Voucher Program. POLM began to direct her to resources to increase her income, assisted her with budgeting, and provided a referral for Mental Health services. After 30 days in the motel, she was enrolled in the POLM Community Shelter.

While in the shelter, she completed an Emergency Housing Voucher application. She was approved and began looking for housing immediately. With the support of POLM Street Outreach, she located a unit and was assisted with completing the application and assembling the needed documents. This month she moved into her own place and has a sustainable income. POLM also helped her locate furniture for her unit. Ms. H now has a place to call home and is forever grateful! Thank you to Path of Life Ministries for helping her navigate the system out of homelessness.

On 3/14/2022 HUD announced the CoC FY 2021, awarding them \$13.7 million to fund 22 projects, 808 beds in 561 units.

Phase 39

\$1.2M - 30 Projects 11/01/2021 - 04/30/2023

There were a total of 8 Rental/Mortgage Assistance Providers, a majority of the Phase 39 funding was allocated to them (\$479,352).

\$3.7M - 32 Projects 11/01/2021 - 04/30/2023

There were a total of 24 Other Food Providers, \$1.7 million of the funding was allocated to them.

PROPOSALS IN SUBMISSION

2022 Emergency Solutions Grant (ESG)

- A total of \$330,638 will be available (\$170,638 for Rapid Rehousing and \$160,000 to Street Outreach).
 - The service period from the date of executed Standard Agreement (8/31/2022 was submitted) until the 30th of June, 2023.
- 1 agency will be funded to provided Emergency Shelter and Street Outreach.

2021 Emergency Solutions Grant (ESG)

- The award letter was sent 7/6/2022, contracts is currently working on an agreement. \$312,602 will be available for:
 - Street Outreach \$182,042
 - Rapid Rehousing \$121,362 \$9
 - Administration \$9.198
- Service period date will be from the date of Standard Agreement until the 30th of June 2023.

Homeless Housing, Assistance and Prevention Program Round 3 (HHAP-3)

CoC & COUNTY ALLOCATIONS


- Both allocations have a service period from the date of executed Standard Agreement (TBD) - 6/30/2026
- Application deadline was on 1/23/2021. On 6/4/21, the State notified that the application has been approved and will move forward with the award and disbursement process.
- Eligible Activities: RRH, operating subsidies, street outreach, service coordination, systems support, permanent housing and innovative solutions, prevention and shelter diversion, new navigation centers and emergency shelters

Youth Homelessness Demonstration Program (YHDP)

Update

- As of June 24th, the CoC has officially submitted the YHDP application.
- We are now awaiting the award notification. If awarded, the funds will be used through a coordinated community approach to prevent and end homelessness amongst transitioning aged youth.

HMIS IMIPACT REPORT



HMIS Lead Agency

The purpose of HMIS is to record and store client-level information about the numbers, characteristics and needs of persons who use homeless housing and supportive services and about persons who receive assistance for persons at risk of homelessness over time, to produce an unduplicated count of homeless persons for each Continuum of Care, to understand the extent and nature of homelessness locally, regionally and nationally, and to understand services use and measure the effectiveness of programs.
