4.1 Youth Homelessness Demonstration Program (YHDP) Subrecipient Update

Informational Item

Background: At the last Board of Governance meeting on October 3rd, an updated budget was presented and approved for YHDP. During the last meeting, we also reviewed the Joint Transitional Housing/Rapid Rehousing project through Moreno Valley College (MVC) and are pleased to report that as of October 31st, 2024, all subrecipients have confirmed their commitment to proceed with their respective projects and proposed budget. Since then, the U.S. Department of Housing and Urban Development (HUD) has also executed all project agreements with Riverside County. CoC staff are now diligently working on subrecipient agreements and hope to execute them before the end of the year. Additionally, CoC staff remain committed to integrating the Youth Action Board (YAB) at every level and plan to obtain their support in project implementation, execution, and improvement. All YHDP projects are projected to be fully stood up by April 1st, 2024, and have two years (until March 31st, 2027) to expend their budgets.

5.1 HHAP Funding Recommendations for the Pathways to Home Project

Action Needed

Background: On September 9, 2024, The County of Riverside Department of Housing and Workforce Solutions released a request for proposal for Homeless Housing Assistance Program (HHAP) funding that will create a pathway to permanent housing for 100 individuals. All awarded projects will work collaboratively to provide a streamlined process that will assist individuals progress from unsheltered homelessness to emergency shelter, to permanent housing. Activities to be funded under this RFP are: Street outreach, Operating Subsidies (Emergency Shelter), Rapid Rehousing, Service Coordination, and Diversion Services.

HHAP funding available under this RFP includes:

- Round 3 CoC allocation is \$469,269.76
- Round 4 CoC allocation is \$4,099,350.17 of which \$440,760.34 is set aside for youth specific activities to support emergency shelter and diversion services to supplement youth activities not covered under the Youth Homelessness Demonstration Program (YHDP).

There were a total of thirty-nine proposals received and were reviewed and scored by an independent review panel. Proposals were evaluated based on county's coverage needs, agency's ability and capacity to perform the proposed projects.
