### 4.0 Old Business

4.1 Update and Recommendations on Homeless Housing Assistance and Prevention Program (HHAP) Grant Allocations – Tanya Torno, CoC Manager

**Background:** The HHAP program is administered by the California Department of Business, Consumer Services, and Housing Agency (BCSH) and serves to provide one-time flexible block grant funds to continuums of care, large cities (population of 300,000+) and counties to support regional coordination and expand or develop local capacity to address immediate homelessness challenges. An application for HHAP was submitted on February 15<sup>th</sup>, 2020 and on April 14<sup>th</sup>, 2020, the Continuum of Care (CoC) was awarded a HHAP grant in the amount of \$3,311,372.74.

During its April 16<sup>th</sup>, 2020 meeting, the Board of Governance (BoG) approved for CoC Staff to develop a broadly written Request for Proposals (RFP) for all eligible categories. CoC Staff released the RFP on August 10<sup>th</sup>, 2020 and hosted a non-mandatory bidders’ conference on August 18<sup>th</sup>, 2020. Twenty-eight (28) applications were received with requests totaling \$15.8 million.

Score and Ranking for New Project Recommendations

The CoC HHAP Evaluator’s Committee consisted of 12 non-conflicted members from various service areas and organizations who have experience in housing, community development, and social service programs. Evaluators participated in a Kick-Off Meeting and received an overview of the HHAP program and BoG Funding Principals. As shown in the table below, CoC Staff recommends nine new proposals for funding priority in addition, to supporting investments needed in the Homeless Management Information System (HMIS) and Coordinated Entry System (CES). Funding recommendations are based on evaluation and scoring of application narrative, needs for proposed services in each service area, and compliance with the BoG Funding Principals.

**4.2 2021 Homeless Point-in-Time Count (PIT) – Laura Gonzalez, CoC Planning/PIT Coordinator**

**Background:** Implementation of the 2021 PIT Count will be affected by COVID19. HUD is expected to release the 2021 PIT count methodology guide which includes standards and acceptable methodologies to conduct the PIT Count. It is likely that HUD will not require interview surveys and will rely on collecting data using an observational/headcount approach. The PIT Count Planning Committee will focus on recruiting homeless outreach teams and staff to implement the count instead of relying heavily on community volunteers. Riverside County has selected Wednesday, January 27, 2021 as the tentative date for the count.

**5.0 New Business**

**5.1 City of Riverside: Homeless Emergency Aid Program (HEAP) Bridge Housing Conversion/Capital Improvement Project – Tanya Torno, CoC Manager**

**Background:** On March 4<sup>th</sup>, 2019, the BoG approved \$606,575 in HEAP Capital Improvement Project funding to support the City of Riverside’s (CoR) Bridge Housing Conversion Project located at 2881 Hulen Place, Riverside, CA. The CoR is requesting to reduce the bed capacity from a 45-bed facility to support the development of a 23-bed bridge housing facility instead. This request is needed to support the addition of semi-private quarters (pod style). These new design elements will reduce the risk and spread of COVID-19.

**Recommended Motion:** *Approve the City of Riverside’s capacity reduction request and reduce the number of beds served through the HEAP Bridge Housing Conversion from 45 to 23. Authorize staff to negotiate and finalize the necessary amendments to any subrecipient agreements with the City of Riverside related to the HEAP award.*

**5.2 100-day Challenge to End Senior Homelessness – Marcus Cannon, 100-day Challenge Sponsor**

**Background:** On February 24<sup>th</sup>, 2020, the State announced it had selected the County of Riverside as one of the communities to participate in the first cohort of the Rapid Result Institute’s (RRI) 100-Day Challenges. Through this challenge, the County aimed to house over 140 homeless individuals aged 65

and older by September 3<sup>rd</sup>, 2020. To kick start the Challenge, the County agreed to utilize existing programs dedicated to connecting seniors to housing, such as the County's local implementation of Project RoomKey, the State-initiated program to protect high-risk individuals, prevent the spread of COVID-19 in communities, and moderate the capacity of the hospitals and healthcare system. Since March 23<sup>rd</sup>, 2020, the County's Project RoomKey successfully moved homeless individuals considered "high-risk" during the COVID-19 pandemic, over 140 of whom are 65 and older, off the street, out of homeless encampments, out of shelters, and into motels and hotels. The Challenge focused on transitioning these individuals from hotels and motels into permanent housing and providing the necessary supportive services to ensure they remain stably housed.

### 5.3 Student Homelessness – Carrie Harmon, BoG Secretary/Assistant Director, HHPWS

**Background:** Over 269,000 students in California experience homelessness. In comparison to non-homeless students, students experiencing homelessness are more likely to have higher rates of suspension and chronic absenteeism, lower graduation rates, and lower state-college readiness rates. Many families in California depend on services provided by public school systems and their unique needs are particularly impacted during school closures as a result of COVID-19. Greater coordination between service providers and school districts may be needed to facilitate linkages to coordinate centralized support processes for homeless students and their families. A presentation on this topic is scheduled on the next Continuum of Care (CoC) meeting on December 9<sup>th</sup>, 2020.
