4.1 2022 Emergency Solutions Grant

Informational Only

Background: The California Department of Housing and Community Development (HCD) announced the availability of approximately \$6 million in new federal funds for the Emergency Solutions Grant (ESG) Continuum of Care (CoC) Allocation program. The County of Riverside Continuum of Care (CoC) is eligible to apply for up to \$312,602, of which a minimum of 40% must be set aside to support rapid rehousing activities. The application period began on June 13th, 2022, and all application and required documentation is due Wednesday, August 17th, 2022. Due to the time sensitivity and timeline of the application, staff prepared the application and included the mandatory 40% allocation towards Rapid Re-Housing and 60% towards Street Outreach. Staff will prepare a presentation to the Board of Governance (BoG) before the release of the local Request for Proposals (RFP) and will include an overview of the current funding distributions across each region. This will allow the BoG to further review categories of assistance available (e.g., street outreach, emergency shelter, rapid re-housing, and homeless prevention) and determine whether adjustments should be made.

4.2 Reallocation of HUD Continuum of Care Projects Assigned to Alternatives to Domestic Violence Tanya Torno, HWS Deputy Director

Action Required

Background: Alternatives to Domestic Violence (ADV) has selected not to proceed with operating two of its HUD Continuum of Care (CoC) Rapid Re-Housing projects. The organization is undergoing a major restructuring due to a formal investigation of the former director, which led to the appointment of a new Board and interim director. Upon notification of ADV's decision, Staff reached out to all HUD CoC subrecipients to measure interest and capacity in absorbing both projects and received responses from Queer Works and Lighthouse Social Services. To address the specialized needs of participants served through the two DV Rapid Re-Housing Programs, staff will lead the development of a Memorandum of Understanding (MOU) with all HUD CoC subrecipients and victim service providers such as ADV, Shelter from the Storm, and the Riverside Area Rape Crisis Center. The MOU will serve to formalize the commitment of parties to work together to provide trauma-focused services to survivors of domestic violence.

4.3 Reallocation of California Emergency Solutions and Housing (CESH) I Award Assigned to Social Work Action Group (SWAG) Tanya Torno, HWS Deputy Director

Action Required

Background: Social Work Action Group (SWAG) has selected not to proceed with operating its CESH I Rental Assistance & Flexible Subsidy project. The organization's decision is largely due to rental market conditions and difficulty in finding landlords who are willing to rent to participants. The original RFP released for CESH I was back in 2019 and as a result, staff recommends incorporating the funding available from this project, with a local Request for Proposals (RFP) that will be released for the Homeless Housing Assistance Program (HHAP) 3. This will increase the amount of funding available to support new projects and will provide an opportunity for the Riverside County Continuum of Care (CoC) to strategically develop, identify and invest in projects that align with the newly adopted Five-Year Homeless Action Plan and funding will incorporate solutions such as landlord incentives, master-leasing and leverage partnerships with affordable housing and permanent supportive housing developers.

4.4 Homeless Housing, Assistance and Prevention (HHAP) Round 2 Allocation to Support Senior Liaison Emma Singh, HWS Administrative Services Manager

Action Required

Background: During its October 26th, 2021, meeting, the Board of Governance approved Staff's recommendation to allocate \$78,341.10 to recruit a Senior Adult Homelessness Coordinator to support and oversee all planning coordination efforts to address senior homelessness. This investment is both critical and necessary to support the growing aging population in Riverside County and address inflows of seniors who experience homelessness through cross-sector collaboration. The County of Riverside's Adult Services Division (ASD)— Crisis Response Intervention System (CRIS) serves as the lead county department responding to seniors who are 60 years and older and dependent adults and, in this role, assign a social worker and link eligible seniors and their families to permanent housing and care. CRIS social workers are stationed throughout the county and respond to requests received from the County of Riverside's Continuum of Care through the Adult Services Hotline 1-800-401-0832. Staff recommends the distribution of \$78,341.10 to this department to further enhance the scale in which they can guide and support the CoC's progress towards this response.

Recommended Motion: Approve the allocation of \$78,341.10 to Riverside County's Department of Public Social Services' Adult Services Division.

4.5 Homeless Housing, Assistance and Prevention (HHAP) Round 3 Allocation to Support System Advancements

Action Item

Background: During its Board of Governance (BoG) meeting on June 16th the BoG reviewed the proposed Homeless, Housing Assistance Program (HHAP) Round 3 funding allocations to include in the Riverside County's Continuum of Care (CoC) application due on June 30th, 2022. The motion carried with the condition that the BoG would continue the discussion during its August 18th meeting. Specifically, this action is needed to determine whether an adjustment of the \$1,026,000 towards systems support is necessary for the CoC's Homeless Management Information System (HMIS) and Coordinated Entry System (CES). Following this motion, HWS will release a Request for Proposals to support the launch and implementation of the program in Riverside County.
