4.1 Homeless Housing Assistance and Prevention (HHAP)
Round 2 Capital Project Recommendations

**Background:** On June 4, 2021, the Riverside County Continuum of Care (CoC) received official notification that it's application for \$1,566,822 in HHAP Round 2 Funding had been approved by the Business, Consumer Services and Housing Agency (BCSH). During its Board of Governance (BoG) special meeting on October 26, 2021, the BoG approved the allocation of \$1,018,434.30 for the development/acquisition/rehabilitation towards affordable housing or permanent supportive housing projects targeting homeless individuals, and to support projects applying for capital funding through the state's No Place Like Home (NPLH) and Homekey Initiatives. On November 17, 2021 the CoC released a Request For Proposal (RFP) for developers to apply for this funding. A total of six project proposals were received by two affordable housing developers. After evaluation from our independent review panel, CoC staff is seeking BoG approval for the independent review panel's project recommendations as stated below:
