# 4.1 Homeless Housing Assistance and Prevention (HHAP) Round 3 Capital Project Recommendations Tanya Torno, Deputy Director

#### No Action Needed

**Background:** On January 31, 2023, the Riverside County Continuum of Care (CoC) entered a standard agreement with the Business, Consumer Services and Housing Agency (BCSH) to receive \$3,365,759.90 in HHAP Round 3 funding. The Board of Governance (BoG) approved the allocation of \$1,000,000 in HHAP Round 3 for the development/acquisition/rehabilitation towards affordable housing or permanent supportive housing (capital) projects targeting homeless individuals. On April 24, 2023, the CoC released a Request For Proposal (RFP) for developers to apply for the \$1,000,000 for capital projects from HHAP Round 3, in addition to a remaining \$218,434.30 for capital projects from HHAP Round 2. One project proposal was received requesting the full amount of \$1,218,434.30 and an independent review panel finalized scoring and evaluation on 6/29/2023. Since the submission and evaluation of the sole proposal, CoC staff was notified that the project has encountered a delay in project readiness relating to the control of the building site. CoC staff has decided to postpone the recommendation to award the applicant until the applicant can confirm that the project will be able to expend all funding before the HHAP Round 3 expenditure deadline of June 30, 2026.

# 4.2 Reallocation of Funding from Transgender Health and Wellness DV Bonus Rapid Rehousing Project Tanya Torno, Deputy Director

## **Action Needed**

**Background:** On March 14, 2022, the Riverside County Continuum of Care received an award of \$2,084,563 to support the County of Riverside DV Bonus Project from the U.S. Department of Housing and Urban Development (HUD) FY2021 Continuum of Care (CoC) Program. Of this amount, \$416,913 was awarded to Transgender Health and Wellness (THW) for the period of performance from August 1, 2022, through December 31, 2023. HWS staff meets with THW each month to provide technical assistance and monitor project performance and has determined that approximately \$185,000 is projected to remain unspent by the end of the performance period of December 31<sup>st</sup>, 2023. HWS Staff is recommending reallocating these funds to His Daughters House (HDH) to administer rental assistance to the targeted population and avoid returning unspent funds to HUD. HDH has experience operating HUD CoC Programs, and specifically, DV funds, and has demonstrated capacity to absorb these funds.

**Recommended Motion:** Approve the reallocation of \$185,000 in DV Bonus Rapid Rehousing Project funds to His Daughters House for the remaining term of this project ending December 31, 2023.

#### 4.3 Allocate Funding from California Emergency Solutions and Housing (CESH) Program

#### **Action Needed**

**Background:** The Riverside County Continuum of Care received two rounds of funding from the state's Department of Housing and Community Development (HCD) to administer the California Emergency Solutions

and Housing Program (CESH): Round 1 - \$1,344,336 and Round 2 - \$747,716. HWS staff have identified a total of \$71,778.69 in savings that need to be redirected towards homeless assistance activities and fully spent by May 6, 2024. Staff is recommending that the funds be allocated to support existing CESH rapid rehousing projects administered by the Coachella Valley Association of Governments (CVAG) and the Coachella Valley Rescue Mission (CVRM). Both agencies have spent 100% of their funding and moving forward with this recommendation will ensure rental assistance dollars remain available to residents in the region.

**Recommended Motion:** Approve the reallocation of \$34,393.59 from CESH I to the Coachella Valley Association of Governments and \$37,385.10 from CESH II to the Coachella Valley Rescue Mission (CVRM) for the period of performance from September 1<sup>st</sup>, 2023, through May 6, 2024.

#### 4.4 2023 HUD Continuum of Care Program Funding Recommendations

#### **Action Needed**

**Background:** The U.S. Department of Housing and Urban Development (HUD) has made available \$13,824,093 in Annual Renewal Demand (ARD) funding to the Riverside County Continuum of Care (CoC) through its Fiscal Year 2022 Continuum of Care (CoC) Program Notice of Funding Opportunity (NOFO). This includes \$1,044,137 in CoC Bonus and \$1,491,624 in Domestic Violence (DV) Bonus funding to support new projects. The CoC released a local Request for Proposals on August 3rd, 2023, providing applicants through August 21st, 2023, to submit all renewal and new applications. 25 applications were received: 19 to support existing and renewal projects and (3) CoC and (2) DV New Bonus applications. The CoC's Independent Review Panel (IRP) met on Wednesday, August 31<sup>st</sup> to review final scores for new projects and the ranking and tiering of CoC renewal and new bonus applications.

#### 4.5 Continuum of Care Impact Report

### Tanya Torno, Deputy Director

#### No Action Needed

**Background:** HWS staff is collaborating closely with the County of Riverside Continuum of Care (CoC) to evaluate and measure the effectiveness of its homeless delivery system. In the last fiscal year spanning from July 1, 2022, to June 30<sup>th</sup>, 2023, the CoC aided 17,260 unduplicated individuals, which reflects a 26% rise in the number of people assisted compared to the previous fiscal year. Remarkably, a total of 5,186 were linked to permanent housing, significantly exceeding the number of placements into housing from the previous year.

The benchmarks below are from our 5-year Homeless Action Plan:

Goal 1	Number of people successfully exiting to housing each month/year exceeds the people entering homelessness each year.	5,186 individuals placed into housing/4,226 individuals entered homelessness
Goal 2	50% reduction in the length of stay for people experiencing homelessness.	3% reduction
Goal 3	75% reduction in the number of people experiencing unsheltered homelessness discharged from institutions or re-entering from the homeless response system.	42% reduction
Goal 4	25% increase in the number of crisis housing beds in the system, geographically distributed.	*400 new shelter beds are in the pipeline. This will allow us to exceed our goal by 25%.
Goal 5	Increase the number of permanent housing units by 75% from baseline year.	27% increase
Goal 6	75% reduction in the number of people experiencing homelessness for the first time.	3% decrease

Although further investments are necessary to meet each benchmark and ultimately achieve our goal of reducing homelessness to a rare, brief, and non-reoccurring incidence, the current outcomes highlight significant progress and acknowledge the effectiveness of our well-functioning care system.
